### Purpose

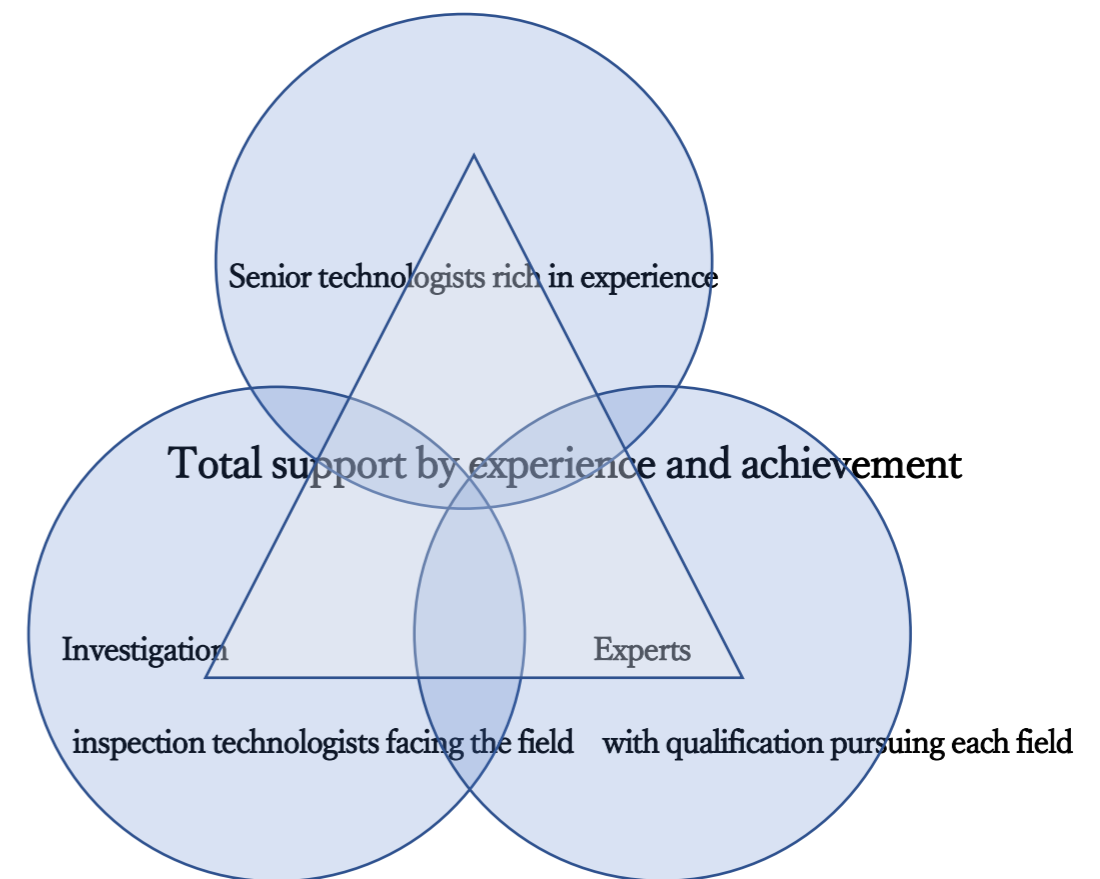
